Supporting schedules

Schedules A through G supply the operational detail behind the titles — including Schedule F (pharmaceutical parity thresholds and royalty schedules) and Schedule G (the complete revenue build-up). Statutory parameters in the schedules are bill text, not estimates.

Evidence standard: Fiscal and impact figures are NSRA model estimates built on published CBO, JCT, OMB, GAO, Treasury, SSA, OECD, and peer-reviewed baselines — internally modeled and sensitivity-tested, not yet officially scored by CBO or JCT, which is pending and welcomed. Statutory parameters (e.g., the \$35 insulin cap, the 50-unit corporate housing cap) are the text of the bill, not projections.
